A complete set of Bidding Documents may be purchased from the office of Nepal Bank Limited, Head Office, General Services Department, Kathmandu, Bagmati Province, Nepal during office hours by the eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs.3,000** till 2079-06-27 during office hours. Or,

Bidder who chooses to submit their bid electronically may download the bidding documents for esubmission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the bank's bid deposit account as specified below.

- 4. Electronic bids must be submitted to the office of Nepal Bank Limited, Head Office, General Services Department, Kathmandu through PPMO website <u>www.bolpatra.gov.np/egp</u> on or before *11:00 hours* on *2079-06-28*. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at *12 hours*

on 2079-06-28 at the office of **Nepal Bank Limited, Head Office, General Service Department, Kathmandu**. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs.1,34,000** which shall be valid for 30 days beyond the validity period of the bid (**total 120 days**)

6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
