Bids shall be opened in presence of Bidders' representatives who choose to attend at 12:30 p:m (for IFB No. NBL/NCB17/G079/80) & at 01:00 p:m (for IFB No. NBL/NCB18/G079/80) on on 2079/10/24 at the office of Nepal Bank Limited, Head Office, General Service Department. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of Rs.1,40,000.00 for IFB No. NBL/NCB17/G079/80) & Rs. 83,000.00 (for IFB No. NBL/NCB18/G079/80) for which shall be valid for minimum 30 days beyond the bid validity period.
- 6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline
