1. Nepal Bank Limited invites *electronic* bids from eligible bidders for the procurement of 26 units of two-wheeler under National competitive bidding – Single Stage Single Envelope procedures.

[The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/cross discounts. Evaluation will be done for each package/lot, with contracts awarded based on the award combination that is of least cost to the Purchaser.]

- 4. Pre-bid meeting shall be held at General Service Department, Head Office at 11:30AM on 2081/06/15
- 5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:30 PM on 2081/07/06. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01:00 PM on 2081/07/06 at the office of General Service Department. Bids must be valid for a period of 90 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.1,15,000.00 for Package A and NRs.55,000.00 for Package B, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2081/11/06)
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
