- 5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before *12pm* on *2082/09/29*. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:15pm, 2082/09/29 at the office of Nepal Bank Limited, General Service Department. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 10,00,000.00 for (Package A) Desktop computers and NRs. 32,000.00 for (Package B) laptops and Rs.10,32,000.00 for both, which shall be valid for 30 days beyond the validity period of the bid 2083/02/29.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
